All SAPR Victim Advocate and SARC candidates must complete the 40 Hour D-SAACP Authorized Course (SAPR VA) prior to submitting your DD2950 for certification through D-SAACP.

T3: D-SAACP certification and completion of the USMC Annual Training Train-the-Trainer course (T3) are required before appointment by the Commanding Officer.
