



RV Park Standard Operating Procedures

Reservations

The RV sites are intended to be used as a temporary rental. They are available to active-duty service members and their dependents, DOD civilians, reservists, retired active-duty, inactive reservists, VHIC-eligible veterans, and caregivers with a VA-issued letter currently enrolled in the VA Program of Comprehensive Assistance for Family Caregivers. Reservations are for the intended patrons as listed in the above statement and their sponsored guests who are listed on the reservation. Subletting RVs aboard Camp Lejeune is prohibited. Per MCO P1700.27B, MCCS shall be responsible for providing all related activities required or desired by the installation, on a continuing basis. Other NAF instrumentalities authorized to operate on a Marine Corps installation, and private organizations, shall not engage in ongoing resale activities, or MCCS-related activities in direct competition with the MCCS operation. MCO 1700.30 states that, unless authorized by contract, direct sale or procurement of any item from vendors to a retail patron is prohibited. Direct sale or procurement from retail patrons to vendors is prohibited.

The Onslow Beach Resort Peak Season is May 1 – September 30 each year. During this time, reservations may be made for a period of 30 days, and after 30 days, the guest shall depart for 7 days before beginning a new reservation. Extensions without a 7-day check-out may be approved based on availability and the manager's discretion. During the non-peak season, October 1- April 30, long-term reservations may be made if space is available.

At the time of booking, RV size and electrical amps will be requested. Guest Service Agents will place reservations in a designated section based on site versus RV size. To verify size, guests must provide RV registration at check-in.

Reservations can be made Monday-Friday, 0800-1800, and weekends 0900-1700. The reservation phone number is 910-440-7502. Reservations may be made according to priority level:

- Level 1 Priority: Active Duty may make reservations 20 weeks in advance.
- Level 2 Priority: Retired Military, VHIC eligible veterans, and caregivers may make reservations 18 weeks in advance.
- Level 3 Priority: Inactive Reservists and DOD employees may make reservations 16 weeks in advance.

Pricing

- Peak Season: \$42 per night. There is no weekly or monthly rate.
- Non-peak Season: \$42 per night. A 30-consecutive-night rate is available at \$510.
- Dry Camping: \$10 per night year-round.



Cancellations

Reservations require full payment at the time reservations are made. Failure to complete payment will result in the reservation being cancelled. Cancellations shall be made 7 days prior to the date of arrival for a full refund to be issued. Cancellations made less than a week before arrival will pay a minimum 1-night stay.

Base Access Information

The Camp Lejeune Visitor Center is located at Bldg. TT-13, adjacent to the Wilson Boulevard Gate, just off N.C. Highway 24. The visitor center processes all visitor applications, excluding contractors and vendors. Those visitors who have not been pre-vetted can expect longer wait times at the Visitor Center.

Please make sure sponsored guests have the necessary documentation required to receive Base Access. Effective Sept. 1, 2025, MCB Camp Lejeune and MCAS New River implemented the REAL ID Act. If a visitor does not have REAL ID, they must provide an approved identity source document or combination thereof to access the installation(s). If a patron is a Veteran with Expanded Access:

To access the installation, veterans and caregivers authorized under the Purple Heart and Disabled Veterans Equal Access Act of 2018 will need to stop by the Camp Lejeune Visitor Center at the Wilson Gate, just off NC-24, or the MCAS New River Visitor Center at the main gate on Curtis Rd. Check-in and Check-out Policy

Check-in time begins at 1200 at the Onslow Beach Guest Services Office located at 275 Beach Rd. Camp Lejeune, NC 28547. Military identification and a credit card on file are required at check-in. If after-hours check-in is required, the Host Camper on Duty will be available at Site 2 or Site 4. Check-out time is no later than 1100. Any late check-outs will be billed as a 1-night service fee of \$42.

Patron Responsibilities

Patrons are responsible for securing and safeguarding their vehicles and any personal belongings. MCCS, the United States Marine Corps, the United States Government, and agents or employees are not responsible for safekeeping or as bailees of the patron's property. Patron vehicles are in areas open to all weather conditions and elements and utilized by other patrons. Patrons accept and "Assume the Risk" of negligence by other patrons; fire, theft, vandalism, acts of God, and any other natural or man-made disasters that may cause damage to or destroy his/her property. It is in the patron's best interest to maintain adequate fire, casualty, and liability insurance to ensure against the risks described above. Any insurance coverage maintained by MCCS does not protect patrons or guests from loss or damage to personal property.



All patrons must adhere to MCIEAST-MCB CAMLEJO 1710.2A.

Guests are responsible for the upkeep of their assigned RV space.

All sewage lines must be raised off the ground, kept level, and secured tightly to prevent leaking. Sewage should not be able to travel upwards at any time. Water hoses should be in operable condition to prevent holes or leaks.

Space Regulations

Each space is limited to house one (1) RV and two (2) vehicles, which includes: automobiles, hauling trailers, and boats. Additional vehicle parking is subject to approval by Onslow Beach Management on a case-by-case basis. Streets, driveways, and common areas will not be used for parking under any circumstances. All non-motorized vehicles (i.e., flatbed trailer, enclosed trailer, boat, etc.) parking is at the discretion of Onslow Beach Management and based on lot size and ability to safely park all vehicles. Any vehicle that cannot be properly parked within the confines of the assigned space shall be parked in the designated overflow parking.

Each patron should be considerate of the overall appearance of the RV Park. Personal property must be capable of being stored within each patron's RV at any time. Patrons should avoid placing excessive items outside that could create clutter or extend beyond the RV space. Personal items located on the outside of the guests' RV must be stored and stacked neatly under the RV.

Non-RV household furniture, gymnasium exercise equipment (free weights are an exception), and animal cages are not permitted to be stored outside at any given time. Guests are not allowed to install permanent fences, outdoor appliances, tarps, mosquito netting, or shading cloth. Gazebos shall not be drilled or nailed into, as a protruding nail in lumber is a safety violation under OSHA standards, creating impalement, cutting, and tripping hazards. Temporary animal fencing (dog must be supervised outside) is allowed.

Clotheslines are permitted to hang in the space within the gazebo, but towels must be brought in once they are dry.

Per Environmental SOP 5090.115A, personal vehicles are not allowed to be under maintenance outside of designated areas such as the Auto Hobby Shop. Section 1F states, "personnel changing private-owned vehicle oil aboard the installation will use established MCCS facilities and deposit used oil/fuel in one of the authorized collection centers".

Recreational vehicles and personal vehicles cannot be washed at Onslow Beach. The base has provided designated wash stations throughout the base to protect the environment. Cleaning chemicals should not be present outside the RV.

Fire pits, tiki torches, and contained fires are prohibited. Grilling is permitted but shall not be done under any awnings or gazebos nor on any wood surfaces. Onslow Beach picnic tables will melt from the heat. Do not grill on top of the Onslow Beach picnic tables.

Propane tanks must be secured at all times to the RV or appropriate equipment. All propane tanks must be tightly secured to prevent leakage.

Amenities:



- 30-amp/ 50-amp / 110-amp electrical outlets

- Free dump station located near dry camp sites

Spectrum TV cable boxes are provided to RV sites. The plastic box includes the cable box, remote, cable, instructions, and charger. If the cable box is not returned in the same condition it was provided, a \$50 replacement fee will be charged to your account.

Quiet Hours

Quiet hours are to be maintained between 2200 and 0700. Television and music should always be kept at a subdued level. Consideration for other patrons is expected.

Pets

Pets are allowed at the RV Park and on Onslow Beach in designated areas. Pets must be compliant with MCIEAST-MCB CAMPLEJO 1710.2A and must abide by the base breed restriction list. Unfortunately, per MCIEAST-MCB CAMLEJO 10570.1, we do not accept the following dog breeds: wolf-hybrids, rottweilers, or pitbulls. Nor do we accept snakes, ferrets, insects, or any other exotic animals. Pets must be on a leash (no longer than 10ft) at all times, and they are not allowed to be outside RV units without supervision. Pets are not allowed to be kept outside, restrained to any object, left in a kennel, or unattended at any time. Pet feces must be picked up by their owners.

Onslow Beach features three dog parks located behind the Bathhouse in the RV Park, behind Osprey Landing, and at the Turtle Trail Lodging area. Owners are asked to bring only well-behaved dogs to the park. Owners are responsible and assume any risks for their pets. Pet Beach is located to the right of the Turtle Trail Pavilion for leashed dogs.

Trash Procedures



Please remove all trash from around your assigned site. Do not leave trash, food, or fish waste outside of the RV. Trash should be placed in the dumpsters located by the Back Circle of the RV Park. This needs to be completed nightly to avoid attracting wildlife.

Beach Rules

Glass bottles and metal detectors are not allowed on the beach. Climbing on dunes is strictly prohibited.

Only authorized Onslow Beach vehicles are permitted to drive on the beach, in accordance with MCIEAST-MCB CAMLEJO 5090.111. In accordance with the MCIEAST-MCB CAMLEJO 5090.115C, all non-registered off-road vehicles (including but not limited to all-terrain vehicles (ATVs), motorcycles (for off-road use), dune buggies, golf carts, and go-karts) are not authorized for use aboard the Installation, except when in use for official government actions. All vehicles on Onslow Beach Island must be driven by licensed drivers. If a guest requires a mobility pass, contact Guest Services to receive the pass. Per Conservation Law Enforcement, a mobility pass, does not allow guests drivable access to the south point of the island.

Patrons must obtain a base permit to hunt, fish, trap, or launch a boat. Individuals 16 years or older must purchase an NC Coastal Recreational Fishing License (CRFL) before recreationally fishing in any water designated as coastal or joint waters of North Carolina. Base permits are required to hunt, fish, trap, or launch a boat on the installation. Hunting is not permitted in the Onslow Beach recreational area. For further information regarding MCIEAST-MCB CAMLEJO 5090.115C.

Onslow Beach is home to many wildlife species, and we specifically cater to the Sea Turtle Program through the Endangered Species Act of 1973. Please be aware of the nesting and hatching season, from May to October. Do not disturb nests. If you are on the beach at night, you only use a flashlight with a red filter.
